PLEASE MAKE NOTE OF THE FOLLOWING:

If you want FIREPAC credit for 2020, you must wait until January 1 to register. FIREPAC contributions made before January 1, 2020 will be applied to the member's 2019 contribution totals.

IAFF members may join the FIREPAC Chairman's Council or FIREPAC Leadership Trust (U.S. and Canada) when registering for Affiliate Leadership Training Summit (ALTS) and Human Relations Conference (HRC). The FIREPAC option is available only to IAFF members. United States federal election law prohibits the solicitation of non-IAFF members.

Your decision to contribute via this FIREPAC option is purely voluntary and the amounts suggested to contribute to FIREPAC are merely guidelines. You are free to contribute more or less than the guidelines and you will not be favored or disadvantaged by reason of the amount of your contribution or decision not to contribute to FIREPAC.

- Your personal, voluntary FIREPAC contribution by personal check or credit card of \$500 or more provides you membership in the Leadership Trust, or \$750 in the Chairman's Council.
- U.S. members who select one of the FIREPAC options to register must submit a personal check payable to IAFF FIREPAC or use a personal credit card. U.S. Members cannot use a union or corporate check/credit card or seek reimbursement for their contribution to FIREPAC.
- One person cannot write a personal check or use a personal credit card to cover multiple registrants contributing to FIREPAC.

Please note that contributions to FIREPAC are not tax deductible and previous FIREPAC contributions and monthly deductions via FIREPAC Check-Off cannot be applied toward the FIREPAC registration option.

The standard registration fee for the Affiliate Leadership Training Summit/Human Relations Conference is \$495.

TWO OPTIONS FOR MAKING FIREPAC CONTRIBUTIONS:

1. FIREPAC Chairman's Council

IAFF members making a personal, voluntary contribution of \$750 or more to FIREPAC will be enrolled in the FIREPAC Chairman's Council and registered for the ALTS and HRC and can attend one pre-conference workshop. Registrants using the FIREPAC option will receive a Chairman's Council pin and a special gift, along with recognition on the IAFF website. Registration must be submitted online or by mail.

2. FIREPAC Leadership Trust

IAFF members making personal, voluntary contribution of \$500 or more to FIREPAC will be enrolled in the FIREPAC Leadership Trust, registered for ALTS and HRC and can attend one pre-conference workshop. Registrants using the FIREPAC option will receive a Leadership Trust pin and recognition on the IAFF website. Registration may be submitted online or by mail.
