



F2T Refund, Transfers and Returns Policy

In-Person F2T Courses and Workshops

- 1) In-person F2T Courses and Workshops are defined as any F2T offering that involves in-person instruction.
- 2) All fees paid by the host department as part of the hosting process are non-refundable. Please contact info@fittothrive.ca for more information (Only applicable to Host Department).
- 3) The refund policy for all in-person F2T Courses and Workshops is as follows:
 - a. If a refund is requested **more than 60 days before** the scheduled start date of the course/workshop, 100% of the course/workshop fee will be returned. Alternatively, registration can be transferred to another individual at no additional cost (see section 4 below).
 - b. If a refund is requested **between 30 and 60 days (inclusive) before** the scheduled start date of the course/workshop, 50% of the course/workshop fee will be returned. Alternatively, registration can be transferred to another individual at no additional cost (see section 4 below).
 - c. If a refund is requested **less than 30 days before** the scheduled start date of the course/workshop, 0% of the course/workshop fee will be returned. Alternatively, registration can be transferred to another individual at no additional cost (see section 4 below).
- 4) The transfer policy for all in-person F2T Courses and Workshops is as follows (NOTE: All transfer requests must be approved by the IAFF and F2T team. No transfers are allowed without proper approval).
 - a. If a request is made to transfer the course/workshop registration to another individual **more than 60 days before** the scheduled start date of the course/workshop, the enrolment can be transferred to the other individual at no additional cost.
 - b. If a request is made to transfer the course/workshop registration to another individual **between 14 and 60 days (inclusive) before** the scheduled start date of the course/workshop, the enrolment can be transferred to the other individual at no additional cost. No additional equipment (t-shirts etc.) will be ordered and it is the responsibility of original registrant to deliver any equipment to the individual taking their place.
 - c. If a request is made to transfer the course/workshop registration to another individual **less than 14 days before** the scheduled start date of the course/workshop, it will be denied.
 - d. Individuals may not transfer their registration from an in-person course/workshop to a synchronous offering of the same course/workshop (see definitions below).

Synchronous F2T Courses

- 1) Synchronous F2T Courses are defined as any virtual F2T offering that involves attending live Zoom sessions with an F2T instructor and accessing relevant course material on F2T's learning management system (LMS).
- 2) The refund policy for all synchronous F2T Courses is as follows:
 - a. If a refund is requested **more than 60 days before** the scheduled start date of the course, 100% of the course fee will be returned. Alternatively, registration can be transferred to a future course at no additional cost.
 - b. If a refund is requested **between 14 and 60 days (inclusive) before** the scheduled start date of the course, 50% of the course fee will be returned. Alternatively, registration can be transferred to a future course at no additional cost.

- c. If a refund is requested **less than 14 days before** the scheduled start date of the course, 0% of the course fee will be returned. However, registration can be transferred to a future course at no cost.
- 3) The transfer policy for all synchronous F2T Courses is as follows:
- a. If a request is made to transfer the course registration to another individual **more than 60 days (inclusive) before** the scheduled start date of the course, the other individual will be given permission to register in the **same course or a future course** at no cost.
 - b. If a request is made to transfer the course registration to another individual **less than 60 days before** the scheduled start date of the course, the other individual will be given permission to **register in the same or a future course** at no cost but will not receive a new equipment package and t-shirt (if applicable). It will be up to the individual requesting the transfer to provide their equipment and t-shirt (if applicable) to the new student.
 - c. If a request is made to transfer the course registration to another individual **less than 14 days after** the scheduled start date of the course, the other individual will be given permission to register **in a future course** at no cost but will not receive a new equipment package and t-shirt (if applicable). It will be up to the individual requesting the transfer to provide their equipment and t-shirt (if applicable) to the new student.
 - d. If a request is made to transfer the course registration with another individual **more than 14 days (inclusive) after** the scheduled start date of the course, it will be denied. No transfers will be granted 14 days after the scheduled start date of the course.

Virtual F2T Workshops

- 1) Virtual F2T Workshops are defined as any virtual F2T offering that does not involve access to F2T's learning management system (Moodle) and content is delivered exclusively through live Zoom sessions.
- 2) The refund policy for all F2T Virtual Workshops is as follows:
 - a. If a refund is requested **more than 14 days (inclusive) before** the scheduled start date of the workshop, 100% of the workshop fee will be returned. Alternatively, registration can be transferred to a future/different workshop at no additional cost.
 - b. If a refund is requested **less than 14 days before** the scheduled start date of the workshop, 0% of the workshop fee will be returned.
 - c. Pre-payments for workshops (purchasing coupon codes to be distributed) are final sale. No refunds will be given. Unused coupons are eligible for credit at future workshops within a 6-month timeframe at time of purchase.
- 3) The transfer policy for all F2T Virtual Workshops is as follows:
 - a. If a request is made to transfer the workshop registration to another individual **more than 7 days (inclusive) before** the scheduled start date of the workshop, the other individual will be given permission to register in the **same workshop or a future workshop** at no cost.
 - b. If a request is made to transfer the workshop registration to another individual **less than 7 days before** the scheduled start date of the workshop, it will be denied.
 - c. No transfers will be granted after the scheduled start date of the workshop.

Asynchronous F2T Workshops and Courses

- 1) Asynchronous F2T Workshops and Courses are defined as any virtual F2T offering that involves delivery of content exclusively through F2T's Learning Management System (Moodle).
- 2) All asynchronous F2T Workshops and Courses are final sale. No refunds will be issued.

Equipment Exchange and Returns

- 1) F2T is unable to process any returns or exchanges of equipment or t-shirts at this time.
