

IAFF ACTIVE-RETIRED MEMBERSHIP

As a retired IAFF member, you already know the importance of engaged union membership. In order for you – as a retired career fire fighter – to maintain an active membership status in the IAFF, you must convert to an **active-retired member status**.

The IAFF continues to fight to protect and enhance the lives of our retirees, which cannot be done without an engaged active-retired membership.

As an active-retired member, you will continue to have access to all IAFF benefits and services provided

to active members, including:

POLITICAL AND LEGISLATIVE DIVISION

Protecting our retired members' pensions and social security benefits.

FINANCIAL CORPORATION

Discounted insurance, banking, retirement, and financial wellness.

UNIONPLUS BENEFITS

Benefits on home/auto buying, shopping discounts, credit cards, legal program, debt settlement, insurance (retiree health, auto, homeowners, renters, life, accident, pet), college degrees, travel, hardship help, moving discounts, etc.

DISASTER RELIEF FUNDS

Available to members who are displaced from their homes as a result of a disaster.

CENTER OF EXCELLENCE

Offering treatment for successful recovery from substance abuse, PTSD, and other behavioral health issues.

FOUNDATION

Supporting members and their families in times of need.

PEER SUPPORT TRAINING

Developing and delivering curriculum to members on approaching a member of concern, establishing trust and confidentiality, providing support, etc.



BURN FUND

Assisting members and immediate family members who suffer a severe burn injury.

EDUCATION AND TRAINING

In-person and online classes on a wide range of topics, including continuing and secondary education opportunities.

OCCUPATIONAL HEALTH, SAFETY, AND MEDICINE DIVISION

Experts and resources in illness/disease, occupational cancer awareness/prevention, behavioral health, safe staffing, health/wellness, building codes, etc.

LEGAL DEPARTMENT

Several policies designed to assist affiliates and members with legal actions.

INTERNATIONAL FIRE FIGHTER MAGAZINE

Providing important news and mailed three times a year to all active-retired members.

HOW TO CONVERT TO ACTIVE-RETIRED MEMBERSHIP:

Contact your IAFF Local to convert your IAFF membership from inactive to active-retired.

Article III – Membership, Section 2. Retiree of the IAFF Constitution and By-Laws state: IAFF members, who have retired from their respective local unions or otherwise withdrawn from their unions as members in good standing, may be allowed to return at the local's choosing within a time period specified for eligibility for active-retiree membership under the local's Constitution & By-Laws.
