Re: Danny L. Todd District Vice President Emeritus

1 WHEREAS, Brother Danny L. Todd started his
2 firefighting career with the Memphis, TN Fire
3 Department on October 30, 1972; and

4 WHEREAS, Brother Todd joined IAFF local
5 1784 on January 29, 1973; and

6 WHEREAS, Brother Todd was appointed
7 Secretary/Treasurer of Local 1784 on October 6,
8 1980, serving for fourteen (14) years and was later
9 elected President of Local 1784 on July 5, 1994,
10 serving for six (6) years; and

11 WHEREAS, Brother Todd was elected IAFF 14th
12 District Vice President taking office in 1995; and

13 WHEREAS, Brother Todd has the distinction of
14 being the most senior District Vice President for the
15 IAFF and serving as a District Vice President longer
16 than any other person in IAFF history serving for
17 thirty-one (31) plus years; and

18 Brother Todd has tirelessly worked on behalf of
19 IAFF members within the 14th District during his
20 time as District Vice President; and

21 WHEREAS, Brother Todd has set examples of
22 service, loyalty, and friendship, providing invaluable
23 knowledge, resources, and guidance to thousands of
24 members and leaders during their times of need; and

25 WHEREAS, Brother Todd has consistently met
26 his obligations to his commitment of “The Fighting

27 14th”; therefore be it
28 RESOLVED, That the delegates assembled at the
29 58th Convention of the International Association of
30 Fire Fighters formally bestow the title of Vice
31 President Emeritus upon Brother Danny L. Todd of
32 the International Association of Fire Fighters.
