FIREFIGHTER KILLED, 13 HURT IN CRASH TRUCK, PICKUP COLLIDE DURING EMERGENCY RUN

An 18-year veteran of the Chicago Fire Department was killed and 13 people were injured Saturday when a firetruck and another vehicle collided on the Southwest Side.

Lt. L.C. Merrell, 43, assigned to Hook and Ladder Co. 24, was thrown from the cab of the truck after the collision with a landscaper's pickup, said Fire Commissioner James Joyce. Merrell, who was married and had four children, died at the scene.

The fire company was responding to a call and its lights and sirens were activated, Joyce said. It was unclear whether Merrell, a passenger in the truck's right-front seat, was wearing a seat belt as required by department regulations, Joyce said.

"We lost one of our best guys today," said Fire Capt. William Vogt. "I served with him for a long time, and he was really good. He was very aggressive and ran a good ship."

Four firefighters, whose identities were not released, and nine people riding in two other vehicles were taken to hospitals. Three remained hospitalized Saturday night.

The accident happened shortly before noon. Firefighters in Company 24's hook-and-ladder truck had just extinguished a minor fire on the Southwest Side when they received orders to respond to a call that turned out to be false.

While northbound on Throop Street at 107th Street, a four-way stop, the firetruck was struck on the passenger side by a westbound Zepeda Construction pickup, said Fire Department spokesman Patrick Howe.

Six people were in the pickup, a Zepeda official said. A midsize sedan near the intersection, with three people inside, was struck by the two trucks.

Joyce said it is standard procedure for drivers of emergency vehicles to stop at intersections to make sure they are clear before continuing. Fire officials are investigating if that procedure was followed.

Chicago police are investigating. No charges had been filed as of Saturday evening.

Joyce did not blame Zepeda's driver for the accident, but he questioned "how a big truck with lights and sirens can be ignored by motorists."

The accident, he said, points to the danger that firefighters and other emergency personnel face en route to calls.

"It's another dangerous part of a very dangerous job," Joyce said.

Sam Zepeda Jr., manager of the South Side family-owned landscaping and construction business, said the pickup's passengers were traveling to a job site to plant trees.

"It's a shock for all of us," said Zepeda, whose uncle was injured in the crash. "We are very sorry as to what happened. We are sorry about the death.

"We have a family business," he added. "It's a small business, and we are all close, very close, with everybody. For us right now, it's a very sad tragedy for everything that has happened."

Accidents involving emergency vehicles account for about 27,000 crashes annually in the U.S. From 1992 to 1997, highway crashes were to blame for 20 percent of the 259 firefighter fatalities nationwide, according to the Bureau of Labor Statistics.

In Chicago, police and fire officials have reported seeing a marked increase in drivers leisurely veering to the side of the road as an emergency vehicle approaches or ignoring the vehicle altogether.

Their concern prompted the city last year to more than quadruple the fine for failing to yield to emergency vehicles, to as much as \$500.

Edward Davidson, who lives near the accident scene, heard the crash as he was getting out of his car.

"It was just a loud boom," Davidson said. The firefighter "had a siren on."

Davidson said that almost immediately, other firefighters and paramedics were on the scene, working to revive the lieutenant, who was lying in the street.

Firefighters and paramedics were able to respond quickly because another hook-and-ladder truck was en route to the same call, Joyce said. A battalion chief, who was driving behind the truck, witnessed the accident.

A 37-year-old firefighter was listed in serious condition and another whose age was not available was listed in fair condition, Saturday night at Christ Hospital and Medical Center in Oak Lawn. Two others were treated and released.

A 45-year-old man, a Zepeda employee, was listed in fair condition Saturday

night at Cook County Hospital with a broken arm and other injuries. A 36-year-old man was treated at Little Company of Mary Hospital and Health Care Center in Evergreen Park and released.

Four men were treated at St. Francis Hospital and Health Center in Blue Island and released. A 38-year-old woman and two girls, ages 4 and 11, were treated at Roseland Community Hospital in Chicago and released.

Flags were lowered Saturday at firehouses throughout Chicago, and black-and-purple bunting will be hung in Merrell's honor at the Company 24 firehouse at 104th Street and Vincennes Avenue, Howe said.

A veteran Chicago Fire Lieutenant was killed and a second firefighter listed in critical condition when a ladder truck responding to a false alarm on Saturday, Apr. 29 was broadsided by a truck that failed to yield the right-of-way at a four-way stop intersection, officials said. Twelve other people were injured, including three firefighters.

According to officials, Truck Company 24 was returning from a response when it

Fire Lieutenant L. C. Merrell and Firefighter Rodney Sevier was ejected from their unit when it was broadsided by a landscape truck in an intersection, officials said.

Merrell, the unit's officer, was pronounced dead a short time after being transported to Christ Hospital. Sevier was listed in fair condition Monday at the same hospital with multiple injuries, police said.

A third firefighter was released from an area hospital Sunday and the two others were treated and released with minor injuries on Saturday, the Chicago Sun-Times reported.

At least nine civlians were injured, none seriously.

Merrell, 43, was an 18-year veteran who is survived by his wife and four children. Their ages were not immediately available early

NVFC Report on "Fallen Heroes Act" was dispatched on an automatic alarm call shortly before Noon on the city's South Side.

The unit had slowed down as it approached a four-way stop at the intersection of 107th and Throop Streets. The landscape truck went through a stop sign, and broadsided the responding unit on the front passenger side.

"There's no criminal negligence, it's just a terrible accident," Sgt. Matthew Brown of the Chicago Police Department's Major Accident Investigation Unit told Firehouse.Com News early Sunday.

The driver of the landscape truck, 56-year-old Isac Zepeda, was issued three traffic citations, including disobeying a stop sign, failure to yield to an emergency vehicle and failure to properly wear a seat belt. More serious charges would not be filed in connection with Merrell's death, Brown said. Six people were travelling in the pickup truck, reports said.

A third vehicle was also involved in the crash. Witnesses in that vehicle told the Chicago Sun-Times that the pickup truck ignored the stop sign.

Officials said they did not know if the firefighters had been wearing the seat belts, the Chicago Sun-Times reported. City regulations require that emergency units have control of an intersection before going through.

"The fire truck slowed down, but it was a four way stop and they had their emergency lights on," Brown said. "[The lights] are a request for a right-of-way to go through, not automatic, but in this case [the fire truck] was already in the middle of the intersection when [it] was [struck]."

Grief counselors were called in to assist those who worked with Merrell and his crew deal with the tragedy. Firefighters were keeping vigil at Christ Hospital for those still hospitalized.



Firefighter killed in crash remembered

Monday, May 1, 2000

A loving husband and father. A friendly, helpful neighbor. A man with a perpetual smile.

That's how neighbors of Chicago Fire Department Lt. L.C. Merrell recalled him Sunday.

Merrell, 43, died Saturday when he was thrown from a fire truck after a truck ran a stop sign and collided with it at 107th and South Throop streets. The medical examiner's office said Merrell died from blunt head trauma.

Louise Abernathy, who lives next door, called Merrell "a very, very, very nice person." Brenda Johnson, who lives on the other side of the Merrell house, called him "a nice, ordinary guy."

"You couldn't ask for a better neighbor," said Abernathy.

"Last week I had three trees out back that needed to be cut down and he did that for me. He just got his saw and cut them down. He was extremely nice and always had a smile," Abernathy said.

The Merrell family, L.C., wife Marilyn, one daughter and three sons, resided in the 3000 block of West 85th Street in the Ashburn neighborhood for about two years, Abernathy said.

A woman who answered the door of the Merrell home Sunday morning said "Mrs. Merrell is not ready to talk about her loss."

The home, with two small American flags hanging near the front door and a pool in the backyard, sits on a quiet residential street across from Hayes Park.

That's the park that Merrell could often be seen walking the family dog or playing catch with his sons, neighbors said.

Streets around the park were clogged with park cars Saturday evening as dozens of mourners paid their respects, Abernathy said.

"Given his job," Abernathy said, "I'd have imagined that if he had died at work, he would have died in a fire."

The firehouse at 104th and Vincennes, where Merrell was stationed, was draped in purple bunting Sunday.

One firefighter shook his head and said "a terrible way to go," when asked about Merrell's death, which happened en route to what turned out to be a false alarm.

The fire truck was heading back from another call when a new call crackled over the radio. The fire truck was hit by a pickup truck owned by Zapeda Construction Co. at the intersection of Throop and 107th Streets.

Isaac Zapeda of Chicago has been ticketed for failure to obey a stop sign, failure to yield to an emergency vehicle and failure to wear a seat belt.

Another firefighter injured in the crash was in fair condition Sunday at Christ Hospital in Oak Lawn with abdominal and neck injuries, fire department spokesman Patrick Howe said. A civilian was in serious condition at Cook County Hospital, he said.

Johnson, who owns a motorcycle, fondly recalled how Merrell always warned her to be careful when riding.

"I was cleaning the motorcycle Friday and he cane out. He shook his head, smiled and told be again to be careful. That's the kind of neighbor he was. He was genuinely concerned," Johnson said.

"I'm devastated," said Johnson, who lit a candle in church Sunday morning as she prayed for Merrell.

Johnson said she planned to prepare a meal for the Merrell family, but wasn't sure how to approach Marilyn.

"What can I say to her that would help make up for her loss? I know she's suffering," Johnson said. "There was a lot of love there. They were tight. I could tell by the way he'd clean her car for her, or warm it up in the winter."

City firefighters honor colleague killed in crash

World News Wire Chicago firefighters bowed their heads in a moment of silence Sunday afternoon over a makeshift flower memorial they had made for their fallen colleague.

The planted marigolds formed "24," the number of Lt. L.C. Merrell's truck company.

Friends and fellow firefighters recalled Merrell as a top firefighter who commanded respect and trust at fire scenes, whose boss valued him so much he recently had asked him not to transfer.

"This guy was an incredibly good fireman," said the Rev. Thomas A. Mulcrone, a Fire Department chaplain. Merrell, the father of five, "was on busy companies all his life."

Merrell was killed Saturday when a pickup truck blew through a stop sign at Throop and 107th Street and collided with the fire truck he was riding in, police said. Another firefighter was seriously injured, but his condition was upgraded from serious to fair Sunday, a Fire Department spokesman said.

One of the men in the pickup truck also was hospitalized in fair condition with a broken arm, the spokesman said.

Chicago police ticketed the pickup truck driver, Isac Zepeda, 55, of Chicago, for failing to stop at a stop sign and other charges, and their investigation continues.

One witness said the landscaping truck was speeding and did not stop. There was no sign of skid marks at the intersection Sunday afternoon.

Chicago Fire Lt. L.C. Merrell would be alive today if he had been wearing his seat belt, Fire Commissioner James Joyce said Tuesday as he vowed to crack down on firefighters who don't buckle up.

"There are things I can't control--building collapses, holes in the floor, things like that. This is something I think I can control," Joyce said.

If Merrell had been wearing his seat belt, Joyce said, "I believe that L.C. would be alive today. I don't want to use this tragic death, but we have to learn something from this ..."

Many firefighters ignore an internal order to wear seat belts because they're too cumbersome to get around heavy equipment, said Bill Kugelman, president of the Chicago Firefighters Union Local 2.

Since April 1992, firefighters have been required to buckle up on their way to fires--emergency gear and all--to prevent precisely the kind of tragedy that occurred Saturday.

FIREFIGHTER'S WIDOW SUES IN FATAL CRASH

CHICAGO The widow of the Chicago firefighter killed when he was thrown from the cab of a firetruck that collided with a landscaper's pickup filed suit Friday in Cook County Circuit Court against the landscaping company and the truck driver.

The suit filed by Marilyn Merrell alleges that defendant Isac Zepeda of Zepeda Construction Inc. failed to yield to the firetruck in which her husband, Lt. L.C. Merrell Jr., 43, was riding and failed to reduce speed to avoid an accident.

The collision occurred April 29 when the vehicle driven by Zepeda allegedly ran a stop sign at 107th and Throop Streets, striking the firetruck.

Neither officials with the firm nor attorneys for Merrell could be reached for comment.
