WHO CAN JOIN?

All full-time, paid employees engaged in firefighting, emergency medical, or rescue service activities are eligible for active membership in the IAFF through chartered locals, state, or provincial associations.

RESOURCES

REPRESENTATION

Assistance with contract negotiations, grievances, arbitration, internal communications, and other union business

FINANCIAL ANALYSIS

Get information on wages, benefits, and working conditions to use in negotiations, arbitration, and meetings with decision-makers.

COMMUNICATIONS

Assistance developing union messages and communications to members, the media, elected officials, and the public.

LEGAL INJUNCTION

Legal representation against unfair discipline for union-related activities.

DATA EVALUATION

GIS mapping, EMS system evaluation, workload analysis, and other data assessments to help educate decision-makers about public safety and the importance of adequate staffing and resource deployment.

POLITICAL AND LEGISLATIVE

Assistance in enhancing and growing political capital, including power mapping, running electoral campaigns, and understanding campaign finance (e.g., Local and state political action committees).

Experts and resources in illness/ disease, occupational cancer awareness/prevention, behavioral health, safe staffing, disaster relief, health/wellness, building codes, etc.

FEDERAL LEGISLATION. IAFF led fight to pass H.R. 82 the **Social Security Fairness Act**, which **eliminated WEP/GPO**, resulting in hundreds of millions of dollars in increases to Social Security for thousands of retired fire fighters (Jan. 2025).

COLLECTIVE BARGAINING RIGHTS.

Irving, TX Local 2073 and Wichita Falls, TX Local 432 both won local ordinances, allowing fire fighters, for the first time, to engage in collective bargaining (Nov. 2024). Atlanta Local 134 wins first-ever collective bargaining agreement (Apr. 2025).

TRAINING & EDUCATION.

Department of Labor (DOL) and IAFF announce a new joint federal apprenticeship program for fire fighters (Apr. 2025).

HEALTH & SAFETY. Quebec, Canada expands cancer coverage for fire fighters brining the province's total to 15 types of cancer deemed occupational (Apr. 2025). Connecticut secures free cancer screenings for fire fighters (Apr. 2025).

HOURS OF WORK. Florida wins a statewide reduced fire fighter workweek to 42 hours (Jun. 2025).
